

As a Pennsylvania beef producer, when selling cattle privately, both you and the buyer are responsible for assuring that the \$1 per head checkoff is remitted. The \$1 is deducted from the selling price of the animal. In private treaty sales it is generally the seller who deducts and remits the \$1.

Under the Beef Promotion and Research Act and Order, a dollar is to be assessed for each bovine animal sold. This includes all bovine animals – bulls, cows, heifers, steers, and calves—regardless of age, sex, breed or purpose of sale. *This applies to beef and dairy cattle as well as veal!* The Beef Checkoff Program also includes all sales where no auction market or other collection point is involved, such as a private sale.
